The morning session featured insightful presentations from representatives of UP, UNI, and UKLO, each sharing their best practices followed by engaging Q&A sessions.
- Day 2: The groups continued their strategic discussions, utilizing collaborative tools such as Google Docs to integrate their ideas into cohesive documents.
- Day 3: The focus shifted to future activities. The day concluded with a consortium meeting to discuss dissemination plans, finances, and overall project progress.

MORIN PROJECT – SIX MONTH PROGRESS UPDATE

Key achievements include:

Project Management Guidelines (D1.1):

A comprehensive guide for partners covering risk, conflict resolution, communication, and finances.

Needs Analysis Report (D1.8):

Provides insights for the forthcoming mapping report in WP2, based on data collected during the project.

• Quality Assurance Manual (D1.9):

Outlines QA procedures and includes templates for reports, surveys, and satisfaction forms, as well as measurable quality indicators like participant numbers, usage statistics, and survey responses.

• Five-Day Exchange Visits (D2.1):

Conducted at UP and UKLO, these visits focused on best practices in recognition processes.

• Literature Review on Mobility Recognition (D2.2):

An open-access literature review report on student mobility's impact, soon available on the project website.

• Self-Assessment Tool (D2.3):

A tool to assess recognition of study periods abroad, available in English and Albanian.

• State-of-the-Art Report (D2.4):

A comprehensive review of WB partners' mobility recognition practices based on the selfassessment tool.

• Training Workshops (D2.7):

Workshops focused on recognition practices and curriculum comparability for WB academic staff.

Dissemination and Sustainability Plan (D4.1):

A strategy for disseminating and sustaining project results beyond the project's funding period, including guidelines and tools for outreach.

• Project Website and Promotional Materials (D4.2):

The project website serves as an interactive platform for sharing project activities, results, and publications, with links to social media and partner networks.
